Add-En-On will seek veterinarian attention and treat accordingly. All expenses will be kept as low as possible and all expenses are the the sole responsibility of the owner and to be paid promptly.

Owners agree to the right to have Add-En-On separate or double any pair of dogs they deem necessary. Rates will change at the time of separation/doubling. All charges incurred during the pets stay are the owner's full and sole responsibility. Any and all charges not paid, or any pets not called upon within 30 days will be treated as "animal neglect" and prosecuted to the fullest extent of the law. Notification will be sent to said owner by registered mail.

The owner represents that he/she is the legal owner of the pet. It is the responsibility of the owner to guarantee that the pet has not been exposed to disease within 30 days, free from parasites and is current with all vaccines required by Add-En-On Kennels.

The word "PET" above in said contract represents any dog, cat, bird, rabbit, fish, ferret, lizard or any other animal that is left to our care.
